Opening of Tender

The purchaser will open the bids after the specified date and time as indicated in the NIT. Authorized representatives of the bidders may attend the tender opening. The EMD for the said tender shall be evaluated first. The statutory papers will be examined and evaluated before evaluation of non-statutory documents. After this, the online price bids or financial bid of only the technically qualified bidders shall be opened for further evaluation.

Opening of Technical Proposals:

Technical proposals will be opened by members of the Tender Evaluation Committee electronically from the e-tender website using their Digital Signature Certificates (DSCs). In the Technical Proposal, the Cover (folder) for Statutory Documents will be opened first and if found in order, the cover (folder) for Non-Statutory Documents will be opened. IF ANY DOCUMENT REQUIRED TO BE SUBMITTED FOR e-TENDER BY THE BIDDER IN HIS TECHNICAL PROPOSAL, BUT NOT SUBMITTED OR IS FOUND TO BE DEFICIENT IN ANY MANNER AT ANY STAGE AFTER OPENING OF BID, THE BID MAY BE SUMMARILY REJECTED.

During evaluation, the Committee will examine the original documents as they are uploaded as e- tender documents. The date & time of such examination of documents will be notified later. TERMS & CONDITIONS:

- 1. Tender Selection Committee (TSC) reserves the right to accept or reject any tender of any part of the tender without assigning any reason whatsoever.
- 2. All bid documents (technical) should be signed/self-attested with seal by the bidder(s) in all pages.
- 3. Incomplete or bid with insufficient documents required for this NIT will be rejected.
- 4. The successful bidder will be required to deposit 5% of the work value for each Machine as security deposit 5% of the total order value as the Security Deposit
- 5. Bidders must attend the Pre-Bid meeting on specific date & time as per the date & time schedule for any queries/ clarification. No queries /clarification will be entertained after opening of Technical Bid thereof. Bidder(s) also may remain present at the time of opening of technical bid.
- 6. The authority will check or test the quality of the Items of each part before finalization of Financial Bid. If any deviation found according to the specification, the authority has every right to cancel the total/part of the tender with forfeiting the security money & EMD.
- 7. The final amount reflects in the financial bid by the bidder(s) will be treated as inclusive of all taxes (direct or indirect) and all charges like cost of material, printing, all incidental charges, fitting, delivery etc. no further or extra charges/amount will be paid beyond the price quoted and approved in the said financial bid.
- 8. The applying Agency/Firm must be registered with PAN, I.Tax, IT return, & P.Tax of current validity.
- 9. The price is to be quoted in INR only including cost of insurance, entry tax, packaging, forwarding, delivery charges, clearing charges and installation of the new instrument. The basic rate should be furnished inclusive of Transportation Cost, Insurance, Testing Charges and Incidental Charges etc. but excluding Excise Duty and cess etc. which should be quoted separately in the template for Bill of Quantities (BOQ). Percentage of Excise Duty, CESS is to be mentioned in the appropriate Column of the template for Bill of Quantities.
- 10. The tendering authority has the liberty to ask for performance demonstration of any item before placing order for supply. In case of dissatisfaction, the authority will have the right to disapprove the offer of L1 bidder and go for the next bidder.
- 11. The tendering authority reserves the right to withdraw any item from the tender at any stage. The selection of such item, if already made in favour of any tenderer, shall be treated as cancelled. The tendering authority reserves the right to reject or accept any tender or part thereof at any stage or to split any tender without assigning any reason. Withdrawal of tender or any revision after submission of tender by the tenderer will not be allowed.
- 12. The rate should be quoted in Indian Rupees for a particular brand or model / model no. of the offered item only as mentioned in the appropriate column of the 'Tender Form'. (Alternative offer will not be accepted). The tender shall be cancelled for the quotation of item without its brand name, model, model no. etc. The detail information regarding the manufacturer and the item quoted in the 'Tender Form' should be furnished.
- 13. The Bidder will undertake that supplies of necessary maintenance equipment and spare parts will be made available for all items/equipment and the complete system for at least five years on a continuing basis. However, this does not relieve the supplier of any warranty obligations under the contract.
- 14. The machine/Instrument should be covered by free on-site comprehensive Warranty for at least two year after successful completion of installation. The tenderers are to quote for 3(there) years' comprehensive on-site warranty of entire system (including all spares & labour) after the date of completion of free warranty period. The CAMC charges for additional 3 years to be quoted in the BOQ should be in accordance with extant Govt. rules in this regard. (i) All faults appearing and their rectification shall be periodically advised to the MSVP, MINMCH, Cooch Behar, the period being not more than two weeks. (ii) Any lacuna or lacunae noticed in

- 15. After sales service must be provided by the supplier, during and after warranty period of the equipment. Selected vendor will remain liable to attract penalty for violation of machine downtime as per agreement. The selected vendor or his authorized servicemen has to attend the machine within 72hours of Call Log.
- 16. Delivery of the goods at the purchaser's premises shall be completed by the Supplier in accordance with the terms specified by the purchaser. (i) The installation, testing and commissioning of the proposed system shall be completed in accordance with the order. (ii). All items are to be delivered within four weeks from the date of placement of order. Iv. In case of distributor, the firm should be direct distributor of manufacturing unit. Sub-distributor authorization by distributor will not be accepted at all.
- 17. PENALTY FOR FURNISHING OF FRADULENT/ MISLEADING DOCUMENTS: If during the tender process or at any stage during the validity of the tender period, it is found that a tenderer(s) has formed a cartel in what so ever form or name to fix up the rates or suppliers to the detriment of the fairness of the tender process, penal measures shall be initiated. Similar penal measures shall also be initiated against those tenderers who have submitted false/ misleading/ fraudulent documents or made incorrect declarations. The penal measure will be forfeiture of Earnest Money, forfeiture of Performance Bank Guarantee if enlisted as a supplier.
- 18. Before submitting the tender, the intending tenderers should thoroughly get acquainted themselves with the proposed supply and installation by local inspection of site and take into consideration the site condition and other criterion for effecting smooth supply. No claim whatsoever will be entertained afterwards.
- 19. Only Manufacturers or authorized distributors are eligible for quoting. The price is to be quoted in Indian Rupees including cost of insurance, packing, forwarding, freight charges, clearing charges and installation of the new instrument and exclusive of all taxes which are to be quoted separately in the BOQ. Agency commission is not permissible.
- 20. Copy of agreement between the manufacturer and the Distributor should be submitted (where bid is submitted by distributor)
- a. Application in the prescribed format, duly filled in & signed in, should be submitted
- b. Authorization letter of signatory from Company should be submitted

Name of the Instrument: Automated Blood Culture System

- 1. Automated modular system with fluorescence/colorimetric technology for culturing, of bacteria, yeast/fungi.
- 2. The system also might have the facility of detection of Mycobacterium tuberculosis and other atypical Mycobacterium from the body fluids and sputum.
- 3. It should have minimum 100 cells in separate or one drawer module.
- 4. Media should be able to detect fungal, aerobic and anaerobic organism from the blood with additional antimicrobial neutralization substances.
- 5. The system should have the capability to process samples of adult and pediatric patients and should have dedicated media for pediatric samples
- 6. The system should have the capability of continuous monitoring of the clinical samples.
- 7. It should have automated continuous instrument quality check facility.
- 8. The system should be provided with printer and UPS and should be able to display growth kinetics on the screen. The system should be modular and upgradeable for future requirements.
- 9. The system should have the capability of analyzing and detection of delayed entry of specimens at growth, stationary and decline stage (both log & lag Phase).
- 10. Detection principle of the system should not have any bottle puncturing during sample analysis and thus no dangerous aerosols formation
- 11. The system uses plastic bottles for safety and ease of disposal.
- 12. The product should be US-FDA Approved.

Name of the Instrument: Automated ID/AST Instruments

- 1. Analytical parameters: System must work on colorimetric technology for identification and susceptibility testing.
- 2. Panel capacity: The system must have the capacity to accommodate a maximum of 60 tests (either 60 ID and/or AST tests) or combo, at any time.
- 3. Type of panels: It should have different panels. (ID & AST separately depending on the user to save cost) it should be based on advanced colorimetric principle.
- 4. Panels: Identification and Sensitivty panel of Gram negative bacilli, Gram positive cocci, Yeast and identification panel of Anaerobic organism, Neisseria & Haemophilus organisms.
- 5. Testing base: Should be on disposable sealed bar coded card (ready to use) and automatic transfer of inoculums.
- 6. Data base: The System should have database more than 2000 reference phenotypes.
- 7. Testing time: Ideally be on the same day (between 3 -10 hrs.), which reduces time to result.
- 8. Incubator: On board incubation chamber
- 9. Sample dispensing: System should not require any manual dispensing of Inoculum to avoid human error, it should be done automatically.
- 10. Additional reagents :System to be compatible with cost effective test cards to avoid any extra costs of additional reagents.
- 11. Bar Code: Positive sample identification with the bar code on the card. (ID or AST card)
- 12. Printer: External printer for direct report print outs.
- 13. Software :Should be Windows based, user friendly with touch screen key pad.Should facilitate monitoring of all the functions of a Microbiology lab and infection control procedure (HAI) Comprehensive antibiotic scope including the latest drugs, compliments formulary needs. Should have facility to design user defined alerts and option for designing drug suppression rules as per hospital internal infection control policy (Antibiotic policy)Customized reports, nosocomial and epidemiology reports should also be obtained.
- 14. Installation in India: Minimum 500 installations in the country with reputed Hospitals / Organizations.
